### SCF - DIVIDEND PLAN

#### How does it work?

Members of the Kingman Area Chamber of Commerce who are in good standing and who are policyholders with SCF are eligible for participation.

Each participating member maintains an individual policy and remains responsible to SCF for payroll and premium reporting. The member may have an individual experience rating and will be entitled to premium discount on an individual basis, if eligible.

It is required that approval by the Kingman Area Chamber of Commerce be obtained for participation in the plan.

SCF computes the dividend and distributes it in accordance with the Kingman Area Chamber of Commerce instructions.

#### What are the rewards?

The plan allows members the opportunity to share in an *additional "bonus" dividend* through the Kingman Area Chamber of Commerce.

Each participating member will receive no less than its earned individual dividend and, in addition, will share in the group "bonus" dividend if earned.

#### How can you participate?

The Kingman Area Chamber of Commerce has a dividend plan and if you are an SCF policyholder, but not yet a participating member, we welcome your enrollment. If you are not currently an SCF policyholder, we welcome the opportunity to serve you.
